- 1. Chair Dr. Ray-Shyan Wu welcomed everyone to the meeting and asked the new members nominated by the National Committees to identify themselves. President Dr. Ragab was honoured to be present at this meeting.
- 2. Some members confirmed their attendance at the ICID conference in Morocco, including Professor Watanabe and others, who will attend remotely due to COVID limits. During the meeting, the secretary general urged everyone to engage physically because of the excellent counter-measures in place, such as the vaccination of over 70% of Moroccans.
- 3. A review of all members is included, as well as an introductory paragraph for new members of the working group.
- 4. Vice Chair Dr. Tian created and introduced a home page for the working groups. It is advised that all members log in and update their profiles.

  - Chapter 2: Effect of climate change on AGWM. Nozar indicated that by the end of the year he would send the draught based on the Iran and Iraq cases.
  - Chapter 3: Adaptation to Climate Change in AGWM; Waleed and Ashish indicated they started to collect the references needed globally, mainly using India's experience and classification based on agroecological zones.
  - Chapter 4; Smart water management against the climate change. Jih-Shun Liu will coordinate with Professor Nagano.
  - Chapter 5: Climate Change Case Studies. (Ray-Shyan Wu)
    Chapter 6: Conclusion, based on Other Chapters' Materials

7. For each chapter, a certain photo and materials are required. Case studies will be an important component and a strength. Each individual's input is critical. Before the next meeting, it is a good idea to prepare some items to present. The 26th Conference of the Parties (COP26) will take place in November. # WG-CLIMATE Minutes Item 6: Expected performance in the WWF9


